*“Artwork must arrive at Strathmore in Exhibition Ready condition, complete with necessary hardware for installation and ready to hang with “D”rings. Artwork will be fit with 3/4” “D”rings or larger or No. 2010 Screw Eyes with a small eye at size 209 and above, or any No. 2012 Medium Eye Screw Eyes or larger installed at 1/4 of total height down from top of artwork to ensure Artwork hangs flush to wall. **Cleats and Sawtooth hangers are not suitable with the hanging system.**”*

*“In addition, artists must agree to a 90-day period after the exhibition closes, which sales of work on exhibition during the Event and viewed by the patron at Strathmore are subject to the 30% commission payable to Strathmore by the individual artists upon completion of the sale.”*
